The University of Bremen (Institute for Public Health und Nursing Research) and the Leibniz-Institute for Prevention Research and Epidemiology - BIPS GmbH initiated jointly a Cooperative Research Group for Evidence-Based Public Health. HEAL Press Release

The Health and Environment Alliance (HEAL) has launched figures today showing that exposure to endocrine disruptors may be responsible for up to €31 billion per year in health costs in the European Union.

The clear message is that reaping the huge benefits for health – avoidance of a proportion of cases of infertility, breast and prostate cancer, diabetes and obesity – will only begin once the EU take action to reduce human exposure to endocrine disrupting chemicals.

IARC/WHO and IACR launch new guidelines for for establishing cancer registries

The International Agency for Research on Cancer (IARC), the World Health Organization (WHO), and the International Association of Cancer Registries (IACR) today launch new guidelines for establishing cancer registries. The publication, titled “[Planning and developing population-based cancer registration in low- and middle-income settings](#)”, provides essential guidance on the key steps in planning a registry, including accessing sources of information, monitoring the quality of the data, and reporting results. The guidelines serve as a vital tool to help low- and middle-income countries attain the highest possible standard of cancer registration, and address the limitations and challenges these registries may face. Cancer registries are critical for evaluating the impact of national control programmes, including vaccination, screening, and treatment efforts. They also serve to catalyse research into causes of the disease.

The publication is now available online in pdf format without charge. Print and e-pub editions will soon be released, and will be distributed widely to partner registries around the world, also free of charge. French and Spanish versions are also in preparation.

Do 'walkable' neighborhoods reduce obesity, diabetes? Yes, research suggests

People who live in neighborhoods that are conducive to walking experienced a substantially lower rate of obesity, overweight and diabetes than those who lived in more auto-dependent neighborhoods, according to a pair of studies. Specifically, the studies found that people living

in neighborhoods with greater walkability saw on average a 13 percent lower development of diabetes incidence over 10 years than those that were less walkable.

Health policy researchers lack confidence in social media for communicating scientific evidence

Though Twitter boasts 645 million users across the world, only 14 percent of health policy researchers reported using Twitter – and approximately 20 percent used blogs and Facebook – to communicate their research findings over the past year, according to a new study. In contrast, sixty-five percent used traditional media channels, such as press releases or media interviews. While participants believed that social media can be an effective way to communicate research findings, many lacked the confidence to use it and felt their academic peers and institutions did not value it or respect it as much as traditional media and direct contact with policy makers.

School scheme unable to boost healthy eating, activity among kids

A school-based scheme to encourage children to eat healthily and be active has had little effect, conclude researchers. The findings have relevance for researchers, policy makers, public health practitioners, and doctors, and they suggest that more intense interventions may be required. School based interventions have the potential to reach the vast majority of children, and evidence reviews have suggested some beneficial effect. However, the poor quality of many of the previous trials means their effectiveness may be exaggerated.

HIV/AIDS epidemic in Europe: HIV transmission through injecting drug use

Opioid substitution therapy is one of the best ways to prevent HIV transmission among people who inject drugs. Integrating such therapy with HIV treatment and care is key to addressing the HIV epidemic effectively.

In the WHO European Region, the rate of HIV transmission through injecting drug use has remained relatively high and stable between 2010 and 2012. While decreasing in the east, it increased in the centre and west of Europe. The increase was due mainly to outbreaks in two European Union countries.

In September, WHO/Europe will report on progress in implementing the European Action Plan for HIV/AIDS 2012–2015. Each month until then, we highlight a specific area of the Action Plan – this month, reducing HIV transmission from injecting drug use.

Bibione. Breathe by the sea. The story of a smoke-free beach in Italy

This publication supports the implementation of the WHO Health 2020 policy. It documents a local initiative for a smoke-free beach employing whole-of-government and whole-of-society approaches to address a common public health challenge: smoking and exposure to tobacco smoke in public settings. The publication describes the key steps in developing the initiative, the recruitment of a champion as leader and a number of key messages that could be useful to other regions and countries wishing to take on a similar public health challenge.

The key steps were: recognition of a public health risk, assessment/engagement of stakeholder interest in addressing the risk, enactment of a regulation to reduce the risk (banning smoking on the beach) and information for beachgoers promoting the idea and enforcing the ban. The initiative was spearheaded by a champion who led the action and engaged partners, which made implementation and monitoring possible. Collaborative governance took place through coordination and trust-building between the economic, tourism, health and environment sectors and local authorities.

Health professional mobility in a changing Europe. New dynamics, mobile individuals and diverse responses

Health professional mobility in Europe has become a fast-moving target for policy-makers. It is evolving rapidly in direction and magnitude as a consequence of fundamental change caused by European Union (EU) enlargement and the financial and economic crisis.

Health professional mobility changes the numbers of health professionals in countries and the skill-mix of the workforce, with consequences for health-system performance. Countries must factor in mobility if they are forecasting and planning their workforce requirements. To this end they need clarity on mobility trends and the mobile workforce, and effective interventions for retaining domestic and integrating foreign-trained health workers. Health professional mobility remains an unfinished agenda in Europe, at a time when the repercussions of the financial crisis continue to have an impact on the European health workforce and its patterns of mobility. This book sheds new light on health professional mobility in this changing Europe. It is the second volume of the PROMeTHEUS project, following the previously published country case study volume.

The book goes well beyond situation analysis as it presents practical tools such as a yardstick for registry methodology, a typology of mobile individuals, qualitative tools for studying the motivation of the workforce and a set of concrete policy responses at EU, national and organizational level including bilateral agreements, codes and workplace responses.

In recent decades the health needs of children in Europe have changed. There is more chronic disease than ever before, and inequalities in health and well-being persist. Despite increasingly sophisticated technology, the delivery of care and organizational structures of healthcare services have not evolved sufficiently to meet these challenges.
